Invitation of rate quotation for cleaning of pavements from weed/grass

Sealed rate quotations are hereby invited by the undersigned for the cleaning of pavements from weed/grass, exposing the original paved surface up-to the edge strip as per Sq. mtr. basis for an area approximately 1300 m² in Jorhat Institute of Science and Technology, Jorhat. The filled quotations along with all the required document must reach in the office of the undersigned on or before 17th January, 2024. The Envelope containing the quotation may be sealed and superscribed as under.

Terms and conditions

- 1) The quotations received after this deadline and unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. The offer submitted Fax/Email shall not be considered, and no correspondence will be entertained on this matter.
- 2) Quotations must be on the letter head of the contractor/firm duly signed by the contractor/Proprietor/Partner/Director or their authorized representative. In case of signing of quotation by the authorized representative, letter of authorization must be attached with the quotation.
- 3) Rates must be quoted in Indian rupees (with taxes extra if any must be written separately)
- 4) No overwriting or striking off is permitted in the rate. If found, the quotation shall be summarily rejected.
- 5) The rates quoted must be valid for minimum of 60 days from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- 6) Becoming L1 will not be the sole criteria for awarding of collect order unless the rates are reasonable & justified.
- 7) The contractor/firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:
 - a) Firm shall be registered with the Government of Assam / Central Government.
 - b) The firm shall have valid GST/Other taxes and IT PAN.
 - c) The firm should not be blacklisted by any Govt. Agency/Dept. The firm should submit a self declaration to this effect.
- 8) Work should be completed within 15 days from issue of work order.
- 9) Payment Terms: Payment will be only after satisfactorily completion of the work.
