ORDER

On the recommendation of the Selection Committee (constituted vide Order No. **JIST/GB/2026-27/7167(A-E)**, dated **16/06/2026**), the undersigned, on behalf of the Governing Body of JIST, is pleased to engage the following Assistant Professors on contractual basis at Jorhat Institute of Science & Technology for running PG courses under self-finance mode with the terms and conditions mentioned below:

They are to report to this Institute on **01-08-2026**.

Terms and Conditions:

1. The engagement is valid for **Five (5) months only** for the faculty member in the Physics Department and **Eleven (11) months** for the faculty member in the Mathematics Department and may be extended subject to satisfactory performance.
2. The monthly remuneration of the contractual Assistant Professor is fixed at **Rs. 28,000/- per month**, debitable to the tuition fee of PG admission fee.
3. The contractual Assistant Professor shall have to perform all academic activities as directed by the Principal/HoDs of the respective departments.
4. The performance of the contractual Assistant Professor will be monitored by a Departmental Performance Monitoring Committee.
5. The contractual Assistant Professor shall avail holidays as applicable to the Institute and may avail Casual Leave with prior permission of the Principal. However, special leaves such as Study Leave, Maternity Leave, Child Care Leave, Medical Leave, and Earned Leave, etc., may be allowed with proportionate cuts in remuneration.
6. The contractual Assistant Professor shall devote his/her whole time to the service of the College. In addition to his/her academic assignments, the contractual Assistant Professor has to perform other duties and activities (without any additional remuneration) assigned by the Principal and HoDs of the respective departments from time to time, as the case may be.
7. The rules and conditions governing the number of teaching days and workload shall be as prescribed by the Institute from time to time. The contractual Assistant Professor shall attend the College on all working days as notified by the College to accomplish the assigned tasks.
8. In case of exigencies of work of the College, the contractual Assistant Professor will have to attend the office on weekly off/holidays also, which may be compensated by availing leave of absence by the contractual Assistant Professor, subject to the condition that the contractual Assistant Professor has rendered his/her services for a minimum of six hours on each such weekly off/holiday with the approval of the Principal of the College, in which such extra working day has been served on a weekly off/holiday.
