- 12) Quotations must be on the letter head of the contractor/firm duly signed by the contractor/Proprietor/Partner/Director or their authorized representative. In case of signing of quotation by the authorized representative, the letter of authorization must be attached with the quotation.
- 13) Rates must be quoted in Indian rupees (taxes extra, if any, must be written separately)
- 14) No overwriting or striking off is permitted on the rate. If found, the quotation shall be summarily rejected.
- 15) The rates quoted must be valid for a minimum of 60 days from the date of opening of the quotation and silence of any tender on this issue shall be treated as agreed upon with this condition.
